● What Data We Collect and Process

We may collect your personal data and other information as further described below:

- 1) Contact information includes your name and email address.
- 2) IP addresses.
- 3) Activity Information directly related to your use of the App, includes contact list and or photos.
- 4) Usage data includes the pages of our App you visit, the time and date of your visit, the time spent on those pages, unique device identifiers another diagnostic data.
- 5) Device information includes device types and settings, device identifiers (such as IDFA, IDFV for Android, GAID for IOS), browser types, mobile, wireless, operating system versions, another network information (such as internet service provider name, carrier name and signal strength), and application version numbers.

● How We Use Personal Data

- 1) To provide you with the Service and communicate with you about the Services.
- 2) To improve and develop our communication and Services.
- 3) To secure and protect our App and users and to meet legal requirements.
- 4) To market and promote the App and Service.
- 5) We may use your data for other purposes when you give us consent to do

so.

● **How We Disclose Personal Data**

We provide your personal information to certain third parties:

- 1) With our third party service providers to support our App and Services. For example, we use service providers for data hosting, application development, marketing and user support.
- 2) We reserve the right to use or disclose your personal data if required by law or if we reasonably believe that use or disclosure is necessary to protect our rights, protect your safety or the safety of others, or comply with a law, court order, or legal process.
- 3) With our current and future parents, affiliates, subsidiaries to fulfill your request or for other purposes set in the Notice.

● **Privacy of Children**
